# 2. <u>Curriculum Implementation</u>

### a. Class Pace on Track (+/- 2 weeks)

Starting Quarter 2, coaching conversations with teachers have addressed the Colorado State Standards and to what extent they are teaching them. Consistently, the teachers are showing that the content covered for Weeks 1-12 is within the +/- 2 weeks' window.

Further conversations related to the LCS Scope and Sequence -- the alignment of the LCS classical curriculum with Core Knowledge and Colorado State Standards—reflect a need to update all classes and identify the more areas where the LCS curriculum exceeds the Colorado State Standards. The goal is to complete this before the teachers' last day of out service.

Continued is the weekly review of each teacher's lesson plans. For Weeks 9-12, 86.9% of the lesson plans were submitted: 32 of the 43 teachers have submitted lesson plans

each week, and 5 of the teachers submitted 3 weeks. In general, we find a correlation between strong lesson plans and intentional instruction.

### b. Teacher/CC Weekly Observations (green)

During weeks 9-12, the deans observed 80 classes and conducted 111 debriefing conversations. Over the span of 4 weeks, the observations and debriefing conversations focused on student engagement, student/teacher interactions, classroom management techniques, and teaching rigor. The debriefing conversations focused on professional objectives, weekly lesson plans, grade books updates, and parent communication.

Starting week 13, we are noting how much of the 30 minutes the classroom coordinators are actively engaged with students. We've looked in on classroom coordinators during the Morning Forum which is when time is set aside for students to read. In 12 of the 15 classrooms, the students are reading in student groups or following along while the cc is reading aloud.

### c. Student Observations/Engagement (green)

We have recorded the number of students the teachers speak to, talk to, or in some way acknowledge. The averages of these student/teacher interactions are as follows:

- Weeks 1-4= 65%
- Weeks 5-8 = 82.5%
- Weeks 9-12=85%

We also record the number of students who are attentive during the direct instruction and participate in the discussion and activity. Our expectation is that 100% of the students are engaged at least 80% of the time. We are pleased that for Weeks 9-12, the LCS student engagement average is 87.5%

#### d. Classroom Equipment, Supplies and Tools (green)

No known needs.

#### e. Staff and Student Climate Discussion (green)

It seems that the staff and student climate is positive.

### f. Cross Content Integration (green)

Lyceum Math and English teachers continue to email the content skills that grade level teachers should integrate into their history, math, and science lessons the following week. This integration is noted both in lesson plans and observations.

### g. Core Virtues (green)

No change: In the elementary grades, classroom coordinators teach virtues using the Character First curriculum. The secondary Agora incorporate character qualities into student activities and lessons. The Student Councils are planning 1-2 collaborative

activities surrounding character traits which students from both campuses will participate in together.
Appropriate Test Preparation (green)
Mr. Stout scheduled both an ELA and Math PARCC team training lead by Thompson

Mr. Stout scheduled both an ELA and Math PARCC team training lead by Thompson School district coaches. The focus is to inform teachers on how to prepare LCS students for upcoming PARCC tests by integrating PARCC type questions into the students' daily classwork and homework. This aligns with the LCS focus for student preparation.
